Legends' Alcohol Service Policies 2022:

- In order to sell or serve alcohol you must have a current valid TEAM training card.
Any person aged 18-20 years old with a valid TEAM training card may serve, pour and draw alcoholic beverages in concession stands. Minors may NOT mix drinks nor function as bartenders, cocktail servers or barbacks.
- **No employee or volunteer will drink alcoholic beverages while working an event.**
- **You must ID every guest every time they order a drink.** Do NOT assume the guest is of age simply because he or she is already in possession of alcohol.
- The **ONLY** acceptable forms of valid, stand-alone identification are below. **All forms of ID must be current and will not be accepted if expired.**
 1. A valid photo driver's license or State Issued Identification Card;
 2. A valid passport; or
 3. A valid US Military ID card with photo, name, date of birth and physical description.
- **Legends has a zero-tolerance policy regarding the selling or serving of alcohol to a minor.** Any Legends employee or volunteer selling or serving alcohol to a minor will be discharged immediately, in addition to suffering possible legal consequences.
- **No guest will be served more than or be in possession of more than 2 alcoholic beverages (beer, seltzer, glass of wine) OR 1 mixed/liquor drink.** If you serve a patron a liquor drink, they may NOT purchase any other alcoholic beverage).
- **Never serve an alcoholic beverage to anyone who appears to be impaired.** You have the right to deny service to any customer who appears to be intoxicated or underage. **Management will back you up!**
- **Alcohol cut-off goes into effect 30 minutes before the scheduled end of show.** *Alcohol cut-off may be adjusted depending at Legends' or Manager's discretion and all locations should cut-off alcohol service immediately.*
- **Bartenders MUST use a 1-oz. Posi Pour when preparing all cocktail beverages. NO EXCEPTIONS! All trailing, tailing, over-pouring or "free-pouring" or double pouring** is prohibited and may result in disciplinary action, up to and including termination without notice.**
***doubles may be sold at specifically authorized locations and must be purchased as such. Refer to your bar book and consult your supervisor if you have questions.*
- **Only one bottle of each type of liquor per bartender** may be open at any time in your bar.
- **Consolidating liquor** or "marrying bottles" is absolutely prohibited.
- **When liquor bottles are empty, you must scratch off/through the ABC stickers** and dispose of all bottles.
- **All canned alcoholic beverages must be opened before handing to patrons.**

I have read and understand the Alcohol policies and agree to comply with all points therein. I understand that failure to follow alcohol service policies and procedures will result in disciplinary action, up to and including termination, as well as potential legal consequences. Any violation of these policies by an NFP volunteer will result in removal of the individual, and possibly the entire group, from the program, as well as any legal consequences.
